

PT Puradelta Lestari Tbk Catatkan Pendapatan Usaha Sebesar Rp1,44 Triliun di Tahun 2021

PT Puradelta Lestari Tbk Booked Revenues of Rp1.44 Trillion in 2021

CIKARANG, 8 April 2022 — PT Puradelta Lestari Tbk dan anak Perusahaan ("Perseroan") hari ini mengumumkan Laporan Keuangan yang telah diaudit untuk periode 31 Desember 2021. Perseroan membukukan pendapatan usaha sebesar Rp1,44 triliun dan laba bersih sebesar Rp715 miliar di tahun 2021.

Segmen industri menjadi kontributor utama pendapatan usaha Perseroan dengan sumbangan sebesar Rp1,18 triliun atau sekitar 81,9% dari pendapatan usaha Perseroan. Segmen hunian dan komersial masing-masing menyumbang Rp125 miliar dan Rp117 miliar, atau masing-masing menyumbang 8,7% dan 8,1% dari pendapatan usaha Perseroan. Di samping itu, segmen hotel menyumbang Rp11 miliar atau 0,7% dari pendapatan usaha Perseroan, sedangkan segmen sewa menyumbang Rp8 miliar atau 0,5% dari pendapatan usaha Perseroan.

Direktur dan Sekertaris Perusahaan Perseroan, Tondi Suwanto, menjelaskan lebih jauh mengenai pencatatan pendapatan atas penjualan lahan industri di tahun 2021. "Penjualan lahan industri kepada pelanggan-pelanggan dari sektor otomotif dan turunannya, serta sektor data center, menjadi penopang utama pendapatan usaha di tahun 2021," ujarnya.

CIKARANG, April 8, 2022 - Today PT Puradelta Lestari Tbk and Subsidiary ("the Company") is announcing its audited Financial Statements for the period of December 31, 2021. The Company booked revenues of Rp1.44 trillion and net profit of Rp715 billion in 2021.

Industrial segment became the main contributor of the Company's revenues with a contribution of Rp1.18 trillion or around 81.9% of total revenues of the Company. The residential and commercial segments contributed Rp125 billion and Rp117 billion, respectively, or contributed 8.7% and 8.1%, respectively, of total revenues of the Company. In addition, the hotel segment contributed Rp11 billion or 0.7% of total revenues of the Company, while the rental segment contributed Rp8 billion or 0.5% of total revenues of the Company.

Director and Corporate Secretary of the Company, Tondi Suwanto, explained further regarding the revenue recognition from industrial land sales in 2021. "The industrial land sales to customers from automotive sector and its derivatives, as well as data center sector, are the main contributors of the revenues in 2021," he said.

Perseroan membukukan laba kotor sebesar Rp847 miliar di tahun 2021, dengan marjin laba kotor sebesar 58,8%. Adapun laba usaha tercatat sebesar Rp665 miliar dengan marjin laba usaha sebesar 46,2%.

Laba sebelum pajak Perseroan tercatat sebesar Rp731 miliar di tahun 2021, sedangkan laba bersih Perseroan tercatat sebesar Rp715 miliar di tahun 2021, dengan marjin laba bersih sebesar 49,6%. Melalui hasil tersebut, Perseroan mencatatkan laba bersih per saham sebesar Rp14,83.

Dari sisi fundamental, jumlah aset Perseroan per 31 Desember 2021 tercatat sebesar Rp6,11 triliun, lebih rendah Rp638 miliar atau 9,5% dibandingkan dengan jumlah aset per 31 Desember 2020 sebesar Rp6,75 triliun. Hal ini terutama disebabkan penurunan kas dan setara kas sebesar Rp776 miliar.

Posisi kas bersih Perseroan per 31 Desember 2021 adalah sebesar Rp599 miliar, menurun Rp776 miliar dibandingkan dengan posisi per 31 Desember 2020 sebesar Rp1,38 triliun. "Penurunan posisi kas bersih terutama disebabkan oleh pembagian dividen tunai yang dilakukan Perseroan sepanjang tahun 2021 sejumlah Rp892 miliar," ujar Tondy Suwanto.

Adapun liabilitas Perseroan per 31 Desember 2021 tercatat sebesar Rp763 miliar, lebih rendah Rp461 miliar atau 37,7% dibandingkan jumlah liabilitas Perseroan per 31 Desember 2020 sebesar Rp1,22 triliun. Hal ini terutama disebabkan penurunan liabilitas kontrak Perseroan, baik jangka pendek maupun jangka panjang, sebesar Rp479 miliar

The Company booked a gross profit of Rp847 billion in 2021, with a gross profit margin of 58.8%. The operating profit was recorded at Rp665 billion with an operating profit margin of 46.2%.

The Company's profit before tax was recorded at Rp731 billion in 2021, while the Company's net profit was recorded at Rp715 billion in 2021, with a net profit margin of 49.6%. Through these results, the Company recorded a net profit per share of Rp14.83.

From a fundamental perspective, the Company's total assets as of December 31, 2021 were recorded at Rp6.11 trillion, Rp638 billion or 9.5% lower than the total assets as of December 31, 2020 of Rp6.75 trillion. This was mainly due to a decrease in cash and cash equivalents of Rp776 billion.

The Company's net cash position as of December 31, 2021 was IDR 599 billion, a decrease of Rp776 billion compared to position as of December 31, 2020 of Rp1.38 trillion. "The decrease in the net cash position was mainly due to the distribution of cash dividends by the Company throughout 2021 amounting to Rp892 billion," said Tondy Suwanto.

The Company's liabilities as of December 31, 2021 were recorded at Rp763 billion, Rp461 billion or 37.7% lower than the Company's total liabilities as of December 31, 2020 of Rp1.22 trillion. This was mainly due to a decrease in the Company's contract liabilities, both current and non-current, by Rp479 billion from Rp970 billion as of

dari Rp970 miliar per 31 Desember 2020 menjadi Rp491 miliar per 31 Desember 2021.

Perseroan tidak memiliki utang. Dengan posisi kas yang ada, Perseroan akan mendanai kegiatan operasionalnya untuk meraih pencapaian yang optimal. Perseroan terus berupaya untuk melakukan pengembangan Kota Deltamas untuk mewujudkan Kota Deltamas sebagai kawasan terpadu modern di timur Jakarta dengan memadukan kawasan industri, hunian, dan komersial.
